### *EU Foreign Policy*

**DRC/UK - Human Rights Priority Country update report: July to December 2016**, UK Foreign & Commonwealth Office, February 8

*"The human rights situation in the DRC deteriorated further during the second half of 2016. Armed groups in Eastern DRC remain responsible for the majority of human rights abuses. However, there was also a continued shrinkage of democratic space, particularly in relation to the electoral process as President Kabila's constitutional mandate drew to a close in December. The majority of incidents reported during this period for which the state was responsible related to arbitrary arrests and detentions; attacks on freedom of speech; and extra-judicial killings by state agents. The trend of state involvement in human rights violations continued, including the disproportionate use of force by the security services of the DRC against supporters of the political opposition. The period saw some limited positive developments with some signs of a reduction in sexual violence against women."*



*“Stalled peace talks in Burundi are forcing hundreds to flee every day seeking refuge in neighbouring countries, the United Nations refugee agency warned today, appealing for more support, particularly land to shelter for new arrivals and to ensure protection of children and prevention of sexual and gender-based violence.*

*According to the Office of the United Nations High Commissioner for Refugees (UNHCR), since April 2015, more than 384,000 Burundian refugees have fled to Tanzania (222,271), Rwanda (84,866), Uganda (about 44,000) and the Democratic Republic of the Congo (32,650) and its projections indicate that numbers will cross half-a-million by the end of the year.”*

*“While the Conflict Mineral Rule has discouraged some American companies from purchasing materials sources in the DRC and adjoining countries, there have been both positive and negative unintended consequences, including some job loss and an increase in the profits of certified conflict-free minerals as a result of the Conflict Mineral Rule. In addition to lost livelihoods associated with the Conflict Mineral Rule, the SEC also estimated in 2014 that American companies would be forced to incur upfront costs of \$3 to \$4 billion, with \$200 million per year thereafter.*

*To respond to these unintended consequences, a more effective means of addressing the problems of the DRC and adjoining countries would be a targeted approach to the financing of armed groups violating rights abuses in Central Africa. Section 1502(b) of the Dodd-Frank Act permits the President of the United States to order the Commission to temporarily waive the requirements of the Conflict Minerals Rule for a period up two years upon a reasoned determination that the waiver is in the national security interest of the United States. During this two-year waiver period, the President will immediately direct the Secretaries of State and Treasury to propose an alternative plan utilizing existing and proposed authorities to address such problems in the DRC and adjoining countries. The proposal should take a targeted approach that focuses on breaking the link between commodities and armed groups in the DRC and adjoining countries”.*

"The Ugandan-led Islamist armed group Allied Democratic Forces, known as ADF-Nalu, may be looking to establish a caliphate in eastern Democratic Republic of Congo (DRC), where it has operated since the late 1990s.

[...] Beyond ideology, the ADF groups are reported to be seeking to "exploit natural resources under the North Kivu's fertile ground", and are enlisting the local population to work in illegal mines in this region rich in coltan, a metallic ore.

Unlike other armed groups in the region, who only conscript fighters by force, Bin Hangi said ADF groups use local Congolese touts who trick local residents into becoming recruits. "Those Congolese men recruit civilians right in the city, in villages by promising jobs such as cultivating land or looking for gold in exchange for money. Those recruiters are ADF 'employees': for instance, a recruiter manages to convince five or six local residents, who he brings to the bush. As soon as they are in the forest, he receives money from the ADF," Bin Hangi explained.

After people are taken to the bush, ADF will deny ever promising them jobs, disorientate them and force them to pledge allegiance to their movement. "Those who refuse to adhere are killed. Those who accept are used as soldiers," he added.

Like many Islamist sub-groups operating in East Africa and across the Sahel, Bin Hangi confirmed ADF also recruit children. "In their ranks we know that there are children. When they can't recruit them using deceit, they kidnap them by force. We have documented how pupils are kidnapped on their way to school or in the schools. That's how children are enrolled in these groups." "

*«Ce n'est pas nouveau. Nous sommes habitués à ce genre de rapports. Ils s'inscrivent dans la suite des images faisant état de graves violations des droits de l'Homme, filmées ailleurs et diffusées par les télévisions France 24 et France 3, pour salir le Burundi. »*

*Selon lui, les droits humains sont respectés au Burundi. Il parle de plus de 2500 prisonniers qui sont en train d'être libérés en raison de la grâce présidentielle.*

*Par rapport aux nouvelles lois régissant les ONG locales et internationales, l'assistant du ministre justifie la position gouvernementale : «Elles visent à empêcher la confusion des engagements des uns à ceux des autres. Avec la dernière loi, il y avait des amalgames. Nous voulons que les organisations fonctionnent désormais dans le strict respect de leurs statuts. »*

*Quant à la mesure enjoignant aux ONG étrangères de respecter les priorités fixées par le gouvernement, il souligne que c'est le gouvernement qui maîtrise à fond les désiderata de son peuple. « Comment quelqu'un établi soit aux Etats-Unis soit en Europe, peut-il connaître ce dont les habitants de telle ou telle autre localité ont besoin plus que le gouvernement ? »*

## West and Central Africa: Weekly Regional Humanitarian Snapshot (31 January – 6 February 2017)



### ADVOCACY & FUNDING



On 30 January, the UN Central Emergency Response Fund (CERF) released US\$49 million to assist over 3 million people in Nigeria (\$22 million), Cameroon (\$10 million), Niger (\$10 million) and Mali (\$7 million), as part of the 2017 first underfunded emergencies round. In the Central African Republic, US\$ 6 million were released to support the humanitarian response to new food-related emergencies in the country. This will enable WFP to assist 36,800 people facing food insecurity in the Kaga Bandoro, Bambari and Bria areas following the successive crises that hit the region in recent months.




On 24 February in Oslo, the Government of Norway will host a humanitarian conference on Nigeria and the Lake Chad Region, in partnership with the Governments of Germany and Nigeria. The conference aims to raise political and material support for the humanitarian response in the Lake Chad Basin region. Three thematic segments will focus on education, food security and protection/access. The conference will be preceded by a civil society forum on 23 February.

### DR CONGO



An assessment led by humanitarian partners on 23–28 January in Moba territory in the country's south-eastern Tanganyika region identified over 53,000 displaced persons, some requiring urgent food and WASH assistance. An assessment will take place in the province next week to identify ways to expand the response and prevent the rapid deterioration of the humanitarian situation following a worsening of the inter-community conflict that has been affecting the region over the past months.
